As authorized by A.R.S. § 36-2205, A.A.C. R9-25-803 establishes as a protocol drug box procedures and minimum standard medications required to be carried in a drug box. The rulemaking amends Exhibit 2 of the protocol to include 4 additional drugs. The amendment was approved by the Medical Director of Emergency Medical Service and the Department's two citizen advisory groups, the Emergency Medical Services Council and the Medical Direction Commission. A.R.S. § 36-2205(C) exempts this protocol from the provisions of A.R.S. Title 41, Chapter 6.
