This article also establishes standards for experimental forms of diagnosis or treatment and establishes guidelines for initiation of a peer review committee for examination of experimental forms of diagnosis or treatment. The article clarifies the use of abbreviations for educational background and Arizona medical practice licensure. Finally, procedures are outlined for requesting a rehearing or review of a board decision.
