# **Effective Dates**

A.R.S. § 41-1032(A), as amended by Laws 2002, Ch. 334, § 8 (effective August 22, 2002), states that a rule generally becomes effective 60 days after it is filed with the Secretary of State's Office. The following table lists filing dates and effective dates for rules that follow this provision.
