During a review of the Board's hospital rules in October 2002, G.R.R.C. staff noticed that there are no time-frame rules for the Board's approval of a hospital pharmacy's request to use less than the rules' minimum required 40 hours of pharmacist time per week. It was determined that time-frame rules were needed to address not only this issue, but any time the Board approved a special request by a licensee or permittee to deviate from or waive compliance with a Board rule. The proposed rule adds a new Section R4-23-401. The new Section has the heading, Board Approvals and Special Requests and Time-frames, and will include the requirements for requesting a Board approval required by this Chapter or a special request to deviate from or waive compliance with a requirement of this Chapter and time-frames for approval or denial of the request.
