PDEQ is proposing to amend and/or repeal the above sections. Standards for sources that PDEQ does not have original jurisdiction under A.R.S. § 49-402 are being repealed (Copper Smelters – 17.16.280 – 300, Portland Cement Plants – 17.16.180, and Petroleum Refineries – 17.16.220). Other sections (17.16.130 and 17.16.160) are being amended for corrections to sectional references. A new section, 17.16.180, is being added in Article IV. "New and Existing Stationary Source Performance Standards for Existing Hospital/Medical/Infectious Waste Incinerators" is the new section 17.16.180. These rules are based on federal standards and ADEQ's Rule 18-2-732 (Existing Stationary Source Performance Standards for Existing Hospital/Medical/Infectious Waste Incinerators). Typographical errors are being corrected and the subsections of 17.16.530 are being renumbered. This section is also being amended by adding two new subparts from 40 CFR 63, as codified on July 1, 2004; 40 CFR 63, Subpart IIII – National Emission Standards for Hazardous Air Pollutants (NESHAP): Surface Coating of Automobiles and Light-Duty Trucks; and Subpart PPPP – National Emission Standards for Hazardous Air Pollutants for Surface Coating of Plastic Parts and Products. These incorporations by reference of the NESHAP subparts assure the continued delegation of authority from EPA to PDEQ to enforce the federal standards.
