SP-043-PHS-EMS, EMS 317: Recertification Requirements for an Emergency Medical Technician Who Applies for Recertification within 30 Calendar Days After the Emergency Medical Technician's Certification Has Expired

2. The public information relating to the substantive policy statement:

Substantive Policy Statement #SP-043-PHS-EMS provided that the Arizona Department of Health Services (ADHS) would allow an applicant for recertification as an emergency medical technician (EMT) to apply for recertification within 30 calendar days after the EMT's certification had expired, if the EMT met prescribed requirements that were considered to demonstrate equivalency to the recertification requirements in A.A.C. R9-25-510(F), R9-25-610(E), or R9-25-611(E), as applicable. The rules referenced in Substantive Policy Statement #SP-043-PHS-EMS (A.A.C. R9-25-510, R9-25-610, and R9-25-611) were repealed effective January 3, 2004. Under the current rules, an EMT may not apply for recertification after the expiration date of the EMT's certification unless the EMT has obtained an extension to file for recertification under A.A.C. R9-25-407 or is eligible for an automatic extension for active military service under Governor's Executive Order 2003-10. To alleviate confusion regarding the current applicability of Substantive Policy Statement #SP-043-PHS-EMS and to ensure consistency in the application of the current rules, ADHS is rescinding Substantive Policy Statement #SP-043-PHS-EMS, effective July 1, 2005.
