Notices of Public Information contain corrections that agencies wish to make to their notices of rulemaking; miscellaneous rule-making information that does not fit into any other category of notice; and other types of information required by statute to be published in the *Register*. Because of the variety of material that is contained in a Notice of Public Information, the Office of the Secretary of State has not established a specific format for these notices.

1. **Name of the Agency:** Department of Environmental Quality
Title and its heading: 49, The Environment
Chapter and its heading: 2, Water Quality Control
Article and its heading: 6, Pesticide Contamination Prevention

2. **The public information relating to the listed statute:**

According to A.R.S. § 49-305, the Arizona Department of Environmental Quality (Department or ADEQ) is required to establish a groundwater protection list (GWPL or List) of those agricultural use pesticides that have the potential to pollute groundwater. The Director shall immediately place all pesticides identified under A.R.S. § 49-303(C)(2) and (3) on the List and regulate the use of these pesticides if the pesticide is intended for application to or injection into the soil by ground-based application equipment or chemigation, or if the application site will be flood or furrow irrigated within 72 hours of application of the pesticide based on label recommendations.

3. **The groundwater protection list**

The GWPL is a list of agricultural use pesticide active ingredients (AIs) that have potential to pollute groundwater. An agricultural use pesticide AI is placed on the GWPL for any of the following reasons: 1) fails to comply with the established specific numeric values, 2) environmental fate assessment indicates potential to leach to groundwater, or 3) an active ingredient or degradation product has been detected in groundwater consistent with established testing requirements.

Pursuant to A.A.C. R18-9-301, the Department is publishing the draft 2006 GWPL to provide an opportunity for the public to comment on the active ingredients placed on or removed from the GWPL. The draft 2006 GWPL includes the 87 active ingredients on the 2005 List and one new addition: flonicamid. With this publication, a 30-day public review and written comment period begins. After completion of the 30-day review period, the Department will formulate a response to those comments and make any necessary modifications to the GWPL. The final GWPL will be published in the *Arizona Administrative Register* on or before July 1st and will include a summary of the comments received and the Department's response to those comments. The new GWPL will become effective on December 1, 2006.
