The Department is creating a new article with three new rules. Laws 2006, Ch. 143, § 7 amends A.R.S. § 42-17052 to provide that valuation changes for proposed levy limit calculations after February 10th of the tax year must be approved by the Property Tax Oversight Commission. The new rules will cover when the Commission will consider valuation changes; who can make a valuation change request; and when requests must be made during the tax year.
