To better meet the needs of patients, hospitals would like to provide more than one organized service in a designated area of the hospital. This rulemaking is amending the rules to allow a hospital to designate multi-organized service units that will provide more than one organized service in a specific designated area of the hospital. The rulemaking also adds a definition of "continuing care nursery" to clarify which services may be provided in a multi-organized service unit.

The rulemaking updates several outdated statutory references and the rulemaking removes an unclear provision in R9-10-203 regarding informed consent.

The Department may make further changes to the rules for clarity, to remove or modify outdated language, or to update references and citations.
