

**Deadlines for Publication and G.R.R.C. Schedule**

**2008 Effective Dates**

**A.R.S. § 41-1032(A)**, as amended by Laws 2002, Ch. 334, § 8 (effective August 22, 2002), states that a rule generally becomes effective 60 days after the day it is filed with the Secretary of State's Office. The following table lists filing dates and effective dates for rules that follow this provision. The 2008 Leap-year calendar will reflect the extra day.
