PURSUANT TO A.R.S. § 41-1013(B)(3)**

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. **WHEREAS**, the under treatment of pain is a major public healthcare problem in Arizona with approximately one out of every four citizens experiencing pain that diminishes their health and quality of life; and

**WHEREAS**, medical technology and knowledge exist to relieve or greatly ease the burden of pain, but often is not applied or is applied improperly; and

**WHEREAS**, pain has serious economic consequences for both our state and its citizens, negatively impacting our state economy as a result of medical costs and lost productivity; and

**WHEREAS**, people who suffer from persistent pain are often stigmatized and not informed about their right to effective pain assessment and management; and

**WHEREAS**, increased awareness of potential treatments for pain can lead to much needed, and much deserved, relief; and

**WHEREAS**, a variety of professional and consumer organization exist to advocate for people experiencing pain by increasing awareness of the under treatment of pain, inspiring people to work toward increasing access to appropriate pain management and improving the quality of life of those suffering from chronic pain.

**\* FETAL ALCOHOL SPECTRUM DISORDERS AWARENESS DAY \***

**WHEREAS**, healthy children are the most important resource in the great State of Arizona, and Fetal Alcohol Spectrum Disorders (FASD) pose a serious threat to the potential health of our future generations; and

**WHEREAS**, the U.S. Senate has passed a resolution each year designating September 9th as National Fetal Alcohol Spectrum Disorders Awareness Day, and has called upon all states to observe FASD Awareness Day on this date to signify that on the ninth day of the ninth month of the year, the nation will remember that during the nine months of pregnancy a woman should abstain from alcohol; and

**WHEREAS**, prenatal exposure to alcohol can cause birth defects, cognitive disabilities, learning disabilities, attention deficits, and behavior disorders, impacting school experiences, employment potential and a myriad of social issues; and

**WHEREAS**, half of all women of childbearing age drink alcohol, and half of all pregnancies are unplanned; and

**WHEREAS**, there are more than 9,000 children that are in foster care in Arizona and it is estimated that 80% of these cases involve alcohol or other drug abuse; and

**WHEREAS**, the cost to Arizona taxpayers for services for children and adults with FASD is estimated by the federal government to be \$100 million per year; and

**WHEREAS**, the incidence rate of full FAS is estimated at 1 out of every 500 live births, and the incidence rate of FASD is estimated at 1 out of every 100 live births; and

**WHEREAS**, Fetal Alcohol Spectrum Disorders are entirely preventable.
