# EXECUTIVE ORDERS, PROCLAMATIONS OF GENERAL APPLICABILITY, AND STATEMENTS ISSUED BY THE GOVERNOR PURSUANT TO A.R.S. § 41-1013(B)(3)

The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. With the exception of egregious errors, content (including spelling, grammar, and punctuation) of these orders has been reproduced as submitted.

WHEREAS, Arizona families recognize that a college education is one of the most important things we can do for our children to prepare them for success in life; and

WHEREAS, the constantly rising costs of a college education continue to outpace inflation and, without proper planning, those costs can jeopardize a family's ability to ensure their children have access to higher education; and

WHEREAS, college is an investment that will pay off given that the earnings gap between those with a high school diploma and those with a college degree exceeds \$1 million over a lifetime; and

WHEREAS, over the past decade, education loan volume increased by more than 250 percent to over \$85 billion, and at the end of the period, loans constituted approximately 70 percent of federal financial aid funding; and

WHEREAS, almost two-thirds of college students graduate with debt, and many college graduates repay large amounts of debt long after they have completed their education; and

WHEREAS, it is in the best interest of Arizona families to encourage saving for higher education expenses so that access to educational opportunities is enhanced for our children, grandchildren, and others, without the burden of education loan debt; and

WHEREAS, in accordance with state and federal law, the State of Arizona operates the Arizona Family College Savings Program, a Section 529 college savings plan that offers both state and federal tax advantages to encourage saving for the expense of higher education and to promote educational opportunity for all Arizonans; and

**WHEREAS,** in the ten years that the Arizona Family College Savings Plan has been available, families have opened almost 50,000 accounts and have accumulated over \$350 million in assets to pay for higher education expenses.

WHEREAS, over the course of 45 years, nearly 3,000,000 youth in the United States have been provided a safe living and learning environment on Job Corps campuses nationwide, educating and training 60,000 youth in the United States each year; and

WHEREAS, the Phoenix Job Corps Center and the Fred G Acosta Job Corps Center in Tucson, have been serving Arizona's At-Risk Youth for 35 years by providing Career Technical Training, Career Transition, GED and/or high school diplomas, counseling, social skills, leadership and independent living skills to young people between the ages of 16-24; and

WHEREAS, throughout its more than four decades of existence, Job Corps has successfully provided the Nation's economically disadvantaged youth receive intensive academic remediation, gain employability, learn life skills and receive job placement assistance; and
