The Administrative Procedure Act (APA) requires the full-text publication of all Executive Orders and Proclamations of General Applicability issued by the Governor. In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. With the exception of egregious errors, content (including spelling, grammar, and punctuation) of these orders has been reproduced as submitted.

* DECLARATION OF EMERGENCY * SEDONA FLASH FLOOD

[M09-390]

WHEREAS, on September 10, 2009 an isolated severe storm over the central portion of the City of Sedona produced approximately 2.5 inches of heavy rainfall within a 45 minute period; and

WHEREAS, the heavy rains resulted in significant flooding on Soldier's Wash and several areas of the City which caused extreme peril to public health and safety; and

WHEREAS, the City of Sedona has declared an emergency for this event and has requested state assistance; and

WHEREAS, several houses and businesses were flooded and left with significant damage sue to debris and silt deposits; and

WHEREAS, the most significant public infrastructure impacts are removal of debris deposited by the flood waters as well as damages sustained to roads and drainage channels; and

WHEREAS, the Governor is authorized to declare an emergency pursuant to A.R.S. § 26-303(D); and

WHEREAS, the Legislature has authorized the expenditure of funds in the event of an emergency pursuant to A.R.S. § 35-192;

NOW, THEREFORE, I, Janice K. Brewer, Governor of the State of Arizona, by virtue of the authority vested in me by the Constitution and Laws of the State, do hereby determine that the flash flooding event in the City of Sedona justifies a declaration of a State of Emergency, pursuant to A.R.S. § 26-303(D), and I do hereby:

- Declare that a State of Emergency exists in the City of Sedona due to flash flooding, effective September 10, 2009;
- b. Direct that the sum of \$200,000 from the general find be made available to the Director of the Arizona Division of Emergency Management to be expended in accordance with A.R.S. § 35-192, A.A.C. R8-2-301 to 321, and Executive Order 79-4; and
- c. Direct that the State of Arizona Emergency Response and Recovery Plan be used to direct and control state and other assets and authorize the Director of the Arizona Division of Emergency Management to coordinate state assets.
