In addition, the *Register* shall include each statement filed by the Governor in granting a commutation, pardon or reprieve, or stay or suspension of execution where a sentence of death is imposed. * LUNG CANCER AWARENESS MONTH *

WHEREAS, lung cancer is the leading cause of cancer death in both men and women in Arizona, the United States, and the world, killing more Americans than breast, prostate, and colon cancer combined; and

WHEREAS, in the United States in 2010, it is estimated that 222,520 new cases of lung cancer will be diagnosed and it is estimated that of those diagnosed, 157,300 will die from lung cancer, accounting for nearly 27% of all cancer deaths; and

WHEREAS, it is estimated that in 2010, there will be 4,030 people who are diagnosed with lung cancer in Arizona, and over 2,670 Arizonans will succumb to the disease; and

WHEREAS, causes of lung cancer include smoking, exposure to toxins and known carcinogens, and genetic abnormalities; and

WHEREAS, approximately 80% of lung cancer cases are diagnosed in people who have never smoked or who have quit smoking; and

WHEREAS, lung cancer generally has a relatively poor prognosis and even with treatment, people with advanced non-small cell lung cancer have a 5-year survival rate of less than 5 percent; and

WHEREAS, increased awareness and coordination among all stakeholders – federal, state and local governments, providers, patients, researchers and community groups— is critical to promote the prevention, diagnosis and treatment of lung cancer
