

## 2011 Effective Dates

**A.R.S. § 41-1032(A)**, as amended by Laws 2002, Ch. 334, § 8 (effective August 22, 2002), states that a rule generally becomes effective 60 days after the day it is filed with the Secretary of State's Office.
