#### 2. The subject matter of the proposed rule:

The Department's proposed amendments to R12-15-725 and addition of new rules R12-15-725.01 and R12-15-725.02 are designed to temporarily delay, for the Pinal Active Management Area (Pinal AMA), implementation of the current R12-15-725(B)(3) extinguishment credit allocation factor reduction set to begin on January 1, 2014. To accomplish this, the Department proposes to adopt a rule temporarily delaying, by five years, each annual reduction in the allocation factor.

The new rule will automatically repeal, effective September 15, 2014, at which time the current reduction schedule will become effective again. This temporary delay in the reduction schedule will allow water users and other interested parties in the Pinal AMA to work together to examine conditions within the AMA and offer alternatives for meeting the Pinal AMA's management goal, which could include making the five-year delay permanent through another rulemaking proceeding.
